Traffic Law Myths: Debunked



MYTH: If a police officer makes any mistakes on your traffic ticket, the case will be dropped.

FACT: A ticket will only be dropped for certain errors. Errors on a

traffic ticket are divided between *fatal errors* (those that will have the traffic ticket dropped) and *non-fatal errors* (those that will not have the traffic ticket dropped). If handled in the proper manner at trial, examples of *fatal errors* are: no accused's name on the traffic ticket at all, incorrect fine or total payable recorded on the traffic ticket, the offence not properly listed on the traffic ticket and the officer did not sign the ticket. Examples of *non-fatal errors* are: misspelled name, incorrect address, incorrect driver's licence number, incorrect make or model of vehicle and incorrect licence plate number. Although these types of mistakes will not get a ticket dropped, they may indicate that there are other errors in the police officer's notes that can be used to your benefit.

MYTH: You cannot get a ticket for driving too slowly.

FACT: While it is not a common charge to be laid on a driver, the *Highway Traffic Act* does include a charge for Unnecessary Slow Driving (s. 132), which carries a fine of \$85 and 2 demerit points. The *HTA* section states: "No motor vehicle shall be driven on a highway at such a slow rate of speed as to impede or block the normal and reasonable movement of traffic thereon except when the slow rate of speed is necessary for safe operation having regard to all the circumstances." If an officer believes that your slow driving is causing problems on the road and impeding the flow of traffic, you can be issued a ticket.

MYTH: It is illegal to flash your lights to let other drivers know about a speed trap.

FACT: There is no offence during the day for warning fellow motorists about police officers conducting speed enforcement duties. At night, however, motorists are required to have proper working headlights and flashing lights do not meet this requirement.

MYTH: Having a broken signal light on your vehicle while driving is an offence.

FACT: The *Highway Traffic Act* charge is failing to signal a turn or lane change (s. 142). If your signal light fails but you use the appropriate arm signals out the window to signal a turn or lane change, you have complied with the law. To manually signal a turn or lane change to the left, the driver should "extend the hand and arm horizontally and beyond the left side of the vehicle." To manually signal a turn or lane change to the right, a driver should "extend the hand and arm upward and beyond the left side of the vehicle."

Auto Insurance Consumers' Bill of Rights

Ontario laws require all owners of automobiles to have auto insurance. These laws also give you rights as an auto insurance consumer. The following information highlights many of your rights under the Insurance Act, related laws and regulations.

Consumers' Rights

- 1. You have the right to purchase auto insurance coverage.
- You have the right to be treated fairly by your insurance company.
- 3. You have the right to be given written reasons if you have been denied auto insurance.
- 4. You have the right to keep your policy in place if you pay your premiums and meet the responsibilities.
- 5. You have the right to pay your auto insurance premium in monthly installments.
- You have the right to keep your policy in place if you pay your premium within 30 days following one or two non-sufficient fund (NSF) situations.

- 7. You have the right to be informed in writing if your policy is not being renewed.
- 8. You have the right to change or cancel your insurance policy at
- 9. You have the right to remain with your insurance company even if that company no longer sells insurance through your broker.
- 10. You have the right to know from which companies your broker received quotes and the amounts.
- 11. You have the right to prompt and fair handling of claims.
- 12. You have the right to reasonable repair of your damaged vehicle.
- 13. You have the right to choose a repair shop, tow operator or vehicle rental company.
- 14. You have the right to receive information about accident
- 15. You have the right to dispute your insurance company's refusal to pay benefits.
- 16. You have the right to choose your health care provider.
- 17. You have the right to register a complaint about your insurance company.
